
The information contained on the front side of this Notice of Infraction (NOI) is incorporated by reference in this narrative report.

☒ This incident was audio and video recorded.

On March 20, 2024 I was working uniform patrol. Officer McDonald was on the Yelser Wy overpass running LIDAR on vehicles on 4th Ave S. He notified me he observed WA/CKG6773 going north on 4th Ave S in the 100 block travelling at 38MPH in a 25MPH zone. I saw the vehicle go by me with extremely loud exhaust, which was backfiring and clearly louder than stock exhaust. I initiated a traffic stop at approximately 4th Ave and Union St. The driver was identified as Hudson, Miles. He was told he was being pulled over for modified exhaust and for speeding 13 MPH over the speed limit. While on the traffic stop I further observed that the car had no front license plate attached, the headlights were modified and were displaying a blue color, not amber. Hudson was told that officers would be mailing the citation to him and verified his address. He was given a business card and released.
