On 03/30/2024, at 2216 hours, I, Ofc. Ivanov 8482 and Officer Piper 8737, in the performance of our official duties, were operating as uniformed Seattle Police Patrol Officers in a marked police patrol vehicle 3-Robert-1. While patrolling the O-1 district in the 2400 block of 4th Ave S, we heard a loud vehicle exhaust noise coming from a few hundred yards to the south of our location.

At the time, we had just passed S Lander St and were headed S/B on 4th Ave S. Once the vehicle got closer, we observed a Dodge Charger SRT widebody wrapped into a green tiger pattern drive past us. The Charger was revving up his engine as it was coasting N/B on 4th Ave S. The sound of the exhaust on the vehicle was deafening. We flipped around and got behind the Dodge Charger WA/CKG6773, which came to a stop for a red light at the intersection with S Stacy St. Once the light turned green, the driver of the Charger began to accelerate while continuing to rev his engine. I activated my emergency lights and initiated a traffic stop for SMC 25.08.430 (B) - Sounds created by operation of motor vehicles. (B) Can be clearly heard by a person of normal hearing at least 75 feet away from the vehicle.

Officer Piper contacted the driver, who verbally identified himself as Miles Oliver Hudson, DOB 05/20/2003. Miles stated that he did not have his driver's license on him at this time.

The vehicle was obviously much louder than the stock Dodge Charger SRT Hellcat Widebody should have been. It's obvious that Miles, being a registered owner of the vehicle, modified the exhaust system to make it louder than stock, thus violating SMC 25.08.450 - Modification to motor vehicles.

Officer Piper advised Miles that he would receive a ticket in the mail.
