I. HEARING

1.1 **Date.** The City of Seattle (Plaintiff) brought its Motion for Default against Miles Oliver Hudson (Defendant) on June 18, 2024.

1.2 **Appearance.** The Plaintiff appeared by Ann Davison, City Attorney, and Cindi Williams, Assistant City Attorney, its counsel. Defendant [] did / [] did not appear.

2.4 **Notice.** CRLJ 55(a)(3) does not require service of a Motion for Default on a party who
has not appeared in the action. Defendant was provided a courtesy copy of the Note for Motion,
Motion for Default, Motion for Order of Default Judgment, Declaration of Cindi Williams, and the
proposed orders at least five days prior to the hearing on the Motion.

III. **ORDER**

THIS MATTER having come on regularly upon the Plaintiff's Motion for Default against the
Defendant, and the Court having considered the Plaintiff's motion and associated files and records;

NOW, THEREFORE,

IT IS HEREBY ORDERED that the Defendant is in default for failure to answer or defend this
action.
