DECLARATION OF CINDI WILLIAMS IN  
SUPPORT OF PLAINTIFF'S MOTION FOR  
DEFAULT

I, Cindi Williams, state and declare as follows:

1. I am the Assistant City Attorney for Plaintiff, the City of Seattle, in the above-named action for civil penalties and order of abatement filed with this Court, and make this declaration based on my personal knowledge and belief.
2. On May 7, 2024, my Legal Assistant, Natasha Iquina, asked Seattle Legal Messengers, a company that provides service of process for the City Attorney's Office, to serve the Defendant with the Summons and Complaint in the above-captioned case.
3. On May 10, 2024, F. Marshall, a registered process server (#2022-48) from Seattle Legal Messengers, served upon Defendant Miles Hudson the Summons and Complaint regarding the subject case, SMC Case No. 1240000005, City of Seattle v. Miles Oliver Hudson. Said

1 service was affected by personal delivery to the Defendant at his home at 1430 2nd Ave.,  
2 Seattle. The Declaration of Service was filed with this Court on May 16, 2024, and is attached  
3 hereto as **Exhibit A**.

4 4. Seattle Legal Messengers has billed the City for their service. On May 13, 2024, the City  
5 Attorney's Office received invoice #447684 for \$219.97. A copy of that invoice is attached  
6 hereto as **Exhibit B**.

7 5. Hudson's mother, Rebecca Hudson, emailed the Seattle Municipal Court and the City  
8 Attorney's Office on May 14, 2024, claiming that Defendant's vehicle was in her possession,  
9 and she said that she was "working on getting the car fixed up and up to compliant [sic]." A  
10 true and correct copy of that email is attached as **Exhibit C**.

11 6. Defendant Miles Oliver Hudson sent an email to me and my co-counsel, Magdalena Pratt, on  
12 May 30, 2024 providing a status on his vehicle. A true and correct copy of that email is  
13 attached hereto as **Exhibit D**.

14 7. Defendant Hudson has not served the City with a Notice of Appearance or filed an Answer to  
15 the Complaint, nor has anyone else done so on his behalf.
