SUPPLEMENTAL DECLARATION OF
CINDI WILLIAMS

I, Cindi Williams, state and declare as follows:

1. I am an Assistant City Attorney for Plaintiff, the City of Seattle, in the above-named action for civil penalties filed with this Court, and make this declaration based on my personal knowledge and belief.
2. On July 27, 2024 a video was posted on YouTube on the "947 Fast Pitch TV" account. The 28-minute long video was titled "24 Hours With the Belltown Hellcat! ft. SRT Miles."
3. In the video a man in a mask and sunglasses who says he is "Miles" who is the Defendant in this case. He discusses several topics, including his court cases and loud driving.

1 4. During the video, he discusses the public complaints about his loud driving and he says "Fuck
2 your cats, fuck your children, I don't give a fuck. Wake the fuck up Seattle, I don't care. I
3 don't care."

4 5. Throughout the video, the Defendant's vehicle, the Dodge Charger that is the subject of this
5 case, is shown loudly revving and backfiring.

6 6. He discusses the "\$85,000 fine" and says that "It sucks but it's not the end of the world for
7 me." He later claims that he is not particularly concerned about the fine and can pay the fine
8 in "two and a half months."

9 7. He explains the outcome of the case at bar:

10 Long story short bro, my lawyer, my lawyer cooked out on me, basically. And here's
11 the thing when I'm I am with lawyers bro, I'm not gonna lie, especially my criminal
12 lawyer, I love her, (inaudible) she's great. . . I'm the type of **** that when I hire you,
13 I don't want to hear shit from the court. Because your lawyer can appear for you, you
14 know what I mean? So I hired this lawyer and they basically dropped my case like
15 days before and I wasn't aware. Basic bro, it's a whole little thing, but basically, I'm
16 not gonna lie I'm lowkey at fault though because I thought I could just like pay a ****
17 and it would be done. . . I don't even lie because (inaudible) I'm not gonna lie I'm a
18 very busy person. . . (This excerpt was edited to remove racial slurs.)

15 8. At the end of the video, he discusses the modifications to the vehicle" "I ain't gonna say too
16 much about the exhaust because it'll be used in a court of law, but we got a switchy tune, that
17 bitch loud as fuck."

18 I declare under penalty of perjury under the laws of the State of Washington that the foregoing
19 is true and correct, and that this declaration was executed this 30th day of July 2024, at Seattle,
20 Washington.
