NARRATIVE***In car video(ICV) & Body worn video(BWV) USED***

This report is intended as a summary of the events that occurred under the listed case number. I have paraphrased conversations and do not include any exact sequence of events. For any exact quotes or exact sequence of events, I would refer the reader to my BWV, as it was recording at the time of this incident.

On 05/02/2024 at 1757 hours I Officer Gerber was working uniformed patrol for the Seattle Police Department as unit 2-Robert-11 when I was dispatched to a DV Disturbance call [REDACTED]

The CAD remarks read:

SEE RP REF ONGOING PROBLEM W/ SUSP, AN EXBOYF, STALKING, HARASSING, AND SENDING EXPLICIT VIDEOS OF RP TO OTHERS. NOT IN PROGRESS. RP WANTS A REPORT IN ORDER TO SEEK RESTR ORD. NO WPNS.

I arrived and contacted the complainant S [REDACTED], A [REDACTED] (12/13/2000) who told me the following: She had previously been in a 1.5 month long dating relationship with Hudson, Miles(05/20/2003) describing him as the SRT guy. I had a vague recollection of a news article about a loud vehicle being driven in downtown. She told me that they broke up approximately one month. After breaking up S [REDACTED] told Hudson that she did not want contact from him and did not want to see him. She said she had screen shots of texts proving this. A [REDACTED] blocked Hudson's phone number, but he would continue to call and text her using phone number generating apps.

Hudson came to S [REDACTED]'s place of work [REDACTED] Seattle located at [REDACTED] 1st Ave. He waited in the back parking lot for her to leave work at approximately 0230 hours on 04/28/2024. S [REDACTED] described how he was standing there with a sign that said I'm delusional for you. S [REDACTED] went back inside and asked for assistance from a bouncer. They told Hudson to leave but he did not.

S [REDACTED] described Hudson being in a white BMW SUV being driven by an acquaintance. The driver was described as an Asian female name Alissa. S [REDACTED] believes video surveillance exists of this incident at the rear of the business.

S [REDACTED] called for an Uber and was escorted by approximately six co-workers for her safety. S [REDACTED] took the Uber home and was confronted by Hudson at her residence. They got into a verbal argument and Hudson threw the sign over her fence. S [REDACTED] no longer had the sign but said she had pictures of the sign.

S [REDACTED] told me that Hudson had gone on Twitch Live and had told his followers about going to her workplace and home. I found Hudson's Instagram "SRT.MILES" with a link to his twitch "BLITZSKII". I viewed a portion of the video with blitzskii showing a sign with the name A [REDACTED] on it and describing how he went to her work and home. The video is titled "she left me.." and is 04:55:31 in length. I took a picture of the sign depicted on the video and uploaded it to AXON. The video is viewable at "https://www.twitch.tv/videos/2130850047". I took a photograph of Hudson showing the sign on his twitch and uploaded it to AXON.

S█ told me that yesterday Hudson sent a video to her ex-boyfriend, Carter, Nahziah(08/24/1999). The video depicted S█ and Hudson engaged in sexual intercourse. S█ told me she was aware of the video at the time of its making but had since forgotten about it. She did not give Hudson permission to share the video and thinks he did it to hurt her.

I provided S█ a DV pamphlet and a business card with my name, badge number and the incident number. S█ asked about court orders and I explained more information was available inside the DV pamphlet. I urged S█ to call 911 if Hudson came to her work or home again. I sent S█ a link to AXON for her to upload evidence.

I called Carter who told me the following: Carter confirmed that Hudson sent him the video depicting S█ and Hudson in a sexual act through Instagram. Carter told me he took screen shots of the conversation and downloaded the video in order to send it to S█ to make her aware of what Hudson had done. I sent Carter a link to AXON for him to upload screen shots of the conversation they had. Carter understood and acknowledged that he may need to testify to this in court. I provided Carter with my name, badge number and the incident number.

I called █ and spoke with general manager Lee, Bryeona who told me she was made aware of an incident by one of her door people. Lee said they had video cameras on the exterior of the building but did not know if it captured the incident. I sent her an AXON link to upload any video surveillance evidence.

Probable cause for 9A.46.110 Stalking exists for:

1 (ii) intentionally and repeatedly follows another person

By going to S█'s place of work and S█'s residence.

1 (iii) Intentionally contact, or attempt to contact another after being given actual notice that the person does not want to be contacted

By repeatedly calling and messaging S█ after being told she did not want contact and being blocked.

12A.10.150 - Disclosing intimate images

1. A person commits the crime of disclosing intimate images when the person knowingly discloses an intimate image of another person and the person disclosing the image:
1. Obtained it under circumstances in which a reasonable person would know or understand that the image was to remain private;

2. Knows or should have known that the depicted person has not consented to the disclosure; and

3. Knows or reasonably should know that disclosure would cause harm to the depicted person.

By sending the video to Carter who is S█'s ex-boyfriend.

On 09 May 2024 while working uniformed patrol as unit "1R11" I responded to the residence at [REDACTED] 16 Av S for a report of ongoing harassment from an ex.

Upon arrival I contacted the complainant who said she had previously been dating the suspect, identified as S/Hudson, for approximately two months. Upon separation approximately a month ago, S/Hudson has been increasingly unhinged. Evidently S/Hudson calls himself "SRT Miles" on the internet and often posts videos of himself driving recklessly in a flamboyant Dodge Charger SRT "Hellcat," and engaging in other childish antics for the enjoyment of his followers. He reportedly has over 700,000 followers to whom he complains about V/S [REDACTED] at great length. V/S [REDACTED] showed me one video that depicted S/Hudson inexplicably wearing a black ski mask and complaining to his followers that he was asked to leave by security when he showed up to V/S [REDACTED]'s place of work unannounced.

V/S [REDACTED] told me he has been calling, sending her messages, and leaving voicemails repeatedly, at all hours. V/S [REDACTED] has told S/Hudson multiple times that she does not want to speak with him and has blocked his number, but he utilizes number-generating software to bypass. She showed me one text message where he threatened to post nude images of V/S [REDACTED] online, which he said would be happening later today (09MAY2024). V/S [REDACTED] said he has already sent similar images directly to other persons. She also played a portion of a voicemail for me during which S/Hudson threatened to "crash out." V/S [REDACTED] told me this means doing something reckless and likely injurious to the victim party, up to and including a drive-by shooting or the like.

V/S [REDACTED] said S/Hudson has also revealed her place of work to his followers and as a result she can no longer work there as it is unsafe. She and her associates have been receiving numerous phone calls and messages from many unknown persons, likely S/Hudson's followers, and at all hours.

V/S [REDACTED] is reasonably afraid of S/Hudson and the behavior of his followers who may or may not be acting at his behest. She told me he had never struck her before, however he has held her in a bear hug such that she would be restrained against her will, and would prevent her from leaving his apartment for long periods of time by physically blocking the door and/or locking it.

V/S [REDACTED] told me there is video evidence of the incident where S/Hudson arrived at her work, and provided me with an email address to seek recovering it. I emailed and advised several ways the evidence could be delivered, I have not heard back as of the time of this report.

I also advised V/S [REDACTED] on how to obtain a protection order. I provided her with a business card with my name and serial number and the case number.
