NARRATIVE

On 6/20/2023 at approximately 23:56 I, Officer G. Misselwitz 8904, was working uniformed patrol as 3M3 for the Seattle Police Department when I was added to a threat call at 1500 2nd Ave in the West Edge Garage. The call remarks were as follows: MALE WITH A HANDGUN ACROSS AT WEST EDGE GARAGE. BRANDISHED AT CUSTOMER AT DOOR.

I arrived on scene and was flagged down by the victim/ERIC MAGELSEN and the building security guards on the second floor of the garage. Officers P. Baci, J. Qualls, N. Soldati and I went to the second floor, and I spoke with ERIC.

ERIC told me he was coming back to the parking garage to get his car just a few minutes prior to the call. ERIC went into the elevator vestibule and the suspect/HARLEM BARNES was in the vestibule. HARLEM was blocking the elevators and ERIC asked him to move. ERIC pressed the elevator button, but HARLEM began getting upset and was arguing with ERIC. ERIC began telling HARLEM to just get out of the vestibule. ERIC then stated HARLEM stepped towards him, said "mind your business", and began grabbing something out of his waistband. ERIC saw what he thought was a gun and said HARLEM began to bring it out and point it at him. ERIC quickly got in the elevator and left. ERIC told me that he thought the gun was a small black pistol. ERIC only saw the weapon for a moment before fleeing into the elevator. ERIC told me that the way HARLEM stepped towards him and told him to back off as he pulled the fake gun out, he believed HARLEM had a real gun and he was going to shoot him.

ERIC then met up with security and security called 911. Security guard/FEISAL ALI and his coworker told me they are familiar with HARLEM and said that HARLEM hangs out in that parking garage often. HARLEM generally doesn't cause any problems in the garage, so they normally let him stay.

Neither security guard saw the altercation between ERIC and HARLEM, but they caught it on their surveillance. I sent FEISAL a link to upload the footage via Axon capture. ERIC told me he would recognize HERLEM if he saw him again.

Officers Qualls and Soldati began a sweep of the garage from the top. As they cleared the building, FEISAL told me that their supervisor could see HARLEM in the right-side elevator, riding up and down. We began pressing the elevator buttons on the 2nd floor so the elevator would come to us. Eventually we got the right-side elevator to open on floor 2 and HARLEM was inside. HARLEM was wearing a large puffy coat and had a backpack with him. HARLEM began to grab his backpack as the elevator doors began closing but Officer Qualls was able to catch the door with his foot.

We brought HARLEM out and put him in handcuffs. Officer Qualls and I frisked HARLEM and did not find any weapons on his person. Officer Baciu checked into the open pockets of HARLEM's backpack and found a fake gun at the top of the bag. The fake gun was created by configuring random objects into the shape of a gun and taping them all together and wrapping it in black electrical tape. The object was clearly made to look like a gun and used to threaten ERIC as if it were real.

ERIC and the security guards were standing up the ramp. ERIC and both security guards (who had watched the footage of the incident by now) were able to positively ID HARLEM as the suspect from the harassment incident.

I read HARLEM his rights and told him he was under arrest for harassment. We brought HARLEM down to my vehicle to search him and then to Officer Baciu's vehicle so he could be transported to KCJ. Once at KCJ, HARLEM was medically declined because he said he swallowed drugs. HARLEM was taken to HMC where officers stayed with him so he could be monitored and then booked into jail.

I gave business cards with my name/badge number to ERIC and FEISAL.

The arrest was screened by Sergeant B. Sullivan 8475 on scene.
