17 **MOTION**

18 COMES NOW Ann Davison, Seattle City Attorney, by her undersigned Assistant City Attorney,
19 Kristina Georgieva, and moves this Court for a bench warrant for the arrest of the defendant pursuant
20 to CrRLJ 3.2(J) and/or (k)(1) for violations of a condition of his release from custody, to wit:
21

22 The Defendant was arraigned on one count of Stalking Domestic Violence (DV) and one count
23 Disclosing Intimate Images DV on July 29, 2024, and Conditions of Release were Ordered by the
24 Honorable Seith Niesen; in relevant part, the Defendant was ordered to enroll in EHD (upon posting
25 the bail amount of \$5,000)¹. Additional conditions included the following: “the Defendant shall not
26 post or stream any content on the social media site Instagram and Twitch. No posts/content/streaming

1 or reels are allowed from the social media accounts @srt.miles on Instagram and Blitzskii from any
2 users.”

3 At the same hearing, the Court amended the conditions of release to prohibit Mr. Hudson from
4 driving the Dodge Charger with VIN 2C3CDXL97PH503197 anywhere in the state of Washington.²
5 The Court also found SMC cause number 4240002153 constituted a violation of Mr. Hudson’s
6 conditions of release on cause number 4240000362 and imposed bail in the amount of \$2500, with
7 enrollment in EHM should he post bail.³

9 Mr. Hudson posted bail on both cases and was released.⁴ Almost immediately, Mr. Hudson
10 violated his conditions of release on Case 4240002153 (DV Stalking and Disclosing Intimate Images)
11 by continuing to post content on social media. On August 12, 2024, the Court found by clear and
12 convincing evidence that Mr. Hudson had violated the court's conditions by posting photos of his
13 ankle monitor juxtaposed with his car keys to a new Instagram account with the handle "alone.miles."
14 Based on this finding, the Court forfeited the \$5000 bail that was previously posted on cause number
15 4240002153 and imposed \$15,000 bail in its place.⁵ Because of this violation, the Court also modified
16 the conditions of release in case 4240000362 (Reckless Driving x 2) to encompass the social media
17 order as well. The Court’s order was clear – no posting on social media.

20 On August 13, 2024, Mr. Hudson posted bond, was released and subsequently re-enrolled in
21 EHD with Sentinel.⁶ At a subsequent hearing, Mr. Hudson sought clarification from the Court about

1 his ability to work while on EHM.⁷ The Court ordered Mr. Hudson to provide Sentinel documentation
2 verifying that he is employed by Emerald City Transitional Services, a company owned by his mother,
3 and indicated that the documentation shall comply with Sentinel Requirements.⁸ According to
4 Emerald City Transitional Services' website, the home health agency offers transitional placement for
5 healthy adults and those who are acutely or chronically ill.⁹ According to Mr. Hudson, he works as a
6 "Transitional Agent" and his position requires him to meet clients and take them to look at potential
7 adult family homes.¹⁰ On August 23, 2024, the Court authorized Mr. Hudson to work as long as
8 Sentinel goes through their usual process to verify employment.¹¹

9
10 On September 16, 2024, Sentinel submitted a request to the Court on behalf of Mr. Hudson for
11 court approval to allow Mr. Hudson to be out for work from 5pm to 3 am¹². The status report reads as
12 follows:
13

14 On 09/13/2024 Miles Hudson reported for a compliance appointment. Mr. Hudson failed to
15 provide proof of him working for his Mother and from his therapy ordered through Renton
16 Municipal Court, Mr. Hudson did not provide a timecard or a paystub to show the time and
17 dates worked. Mr. Hudson is requesting to be out from 5pm to 3am, which is considered odd
18 hours of operations especially for him moving elderly into newer homes. As a result Sentinel
19 is asking the court for approval to allow Miles Hudson to be out for work from 5pm to 3am.¹³

20 The Court denied this request and further asked Sentinel to request proof of previous
21 work/therapy hours again.¹⁴

22 On September 30, 2024, Sentinel filed a status report noting that on September 27, 2024, Mr.
23 Hudson failed to report for his compliance appointment¹⁵. Sentinel attempted to call Mr. Hudson but

1 his line was busy, and Sentinel was unable to leave a voicemail at this time. On the same day,
2 Sentinel tried contacting his emergency contact but could not reach them or leave a voicemail due to a
3 busy line. Additionally, Sentinel noted that Mr. Hudson was still leaving at 5pm to 3 am despite not
4 having permission to do so.

5 On October 4, 2024, Sentinel filed another status report noting that Mr. Hudson is not in
6 compliance with program rules and with conditions of release.¹⁶ The report notes the following:

8 On 10/02/2024 Miles Hudson reported for a compliance appointment. Mr. Hudson provided
9 proof of his employment with Emerald City Transitional Services with a paystub. Mr.
10 Hudson however is currently not in compliance with the program rules that were agreed
11 upon. Mr. Hudson from 09/13/2024 to 10/02/2024 had several leaves that were 15 minutes to
12 an hour long that he was not able to provide proof for. Mr. Hudson kept leaving his apartment
13 to let people up, which is not allowed. During this time Mr. Hudson claimed to have ordered
14 DoorDash but was gone for longer than 15 minutes at a time, Mr. Hudson also did not
15 provide proof of these purchases either. Miles also disconnected his phone number and did
16 not let Sentinel know about this change. Mr. Hudson also is not in compliance with his
17 conditions of release. Per his conditions Mr. Hudson is not allowed to post to any form of
18 social media whether that be TikTok, YouTube, Instagram, twitter, etc.
19 Mr. Hudson has posted on his TikTok page recently on 9/25, 9/5, 9/2, 8/27, 8/25, 8/23, 8/19,
20 and 8/16 since he has re-enrolled with Sentinel. Sentinel will update the court regarding
21 anymore violations to his conditions of release or to Sentinel's program rules.¹⁷

22 Pursuant to CrRLJ 3.2(J) and/or (k)(1), the City may by verified application, request the Court
23 to issue a warrant directing the arrest of the accused for immediate hearing for reconsideration of
24 conditions of release pursuant to section (k) of CrRLJ 3.2. The Court should determine custody
25 pending trial and determine a new appropriate bail amount. The City respectfully requests that this
26 Court revoke release and issue a warrant in the amount of \$25,000 on each case for the arrest of the
27 defendant for immediate hearing for reconsideration of conditions of release.
