18 COMES NOW Ann Davison, Seattle City Attorney, by her undersigned Senior Assistant City
19 Prosecutor, Kristina Georgieva, and moves this Court for a bench warrant for the arrest of the
20 defendant pursuant to CrRLJ 3.2(J) and/or (k)(1) for violations of a condition of his release from
21 custody, to wit:
22

23 The Defendant was arraigned on one count of Stalking Domestic Violence (DV) and one count
24 Disclosing Intimate Images DV on July 29, 2024, and Conditions of Release were Ordered by the
25 Honorable Seith Niesen (attached); in relevant part, the Defendant was ordered to enroll in EHD (upon
26 posting the bail amount of \$5,000). Additional conditions included the following: “the Defendant
27 shall not post or stream any content on the social media site Instagram and Twitch. No

1 posts/content/streaming or reels are allowed from the social media accounts @srt.miles on Instagram
2 and Blitzskii from any users.”

3 At the same hearing, the court amended the conditions of release on SMC cause number
4 4240000362 (one count of Reckless Driving). The previous conditions prohibited Mr. Hudson from
5 operating the Dodge Charger bearing the license plate “CKG 6773.” On July 29, the City provided
6 argument and offered proof that Mr. Hudson had changed his license plate through DOL to “Sasuke.”
7 Upon this offer of proof, the Court amended the conditions of release to prohibit Mr. Hudson from
8 driving the Dodge Charger with VIN 2C3CDXL97PH503197 anywhere in the state of Washington.¹
9 The Court also found SMC cause number 4240002153 constituted a violation of Mr. Hudsons
10 conditions of release on cause number 4240000362 and imposed bail in the amount of \$2500, with
11 enrollment in EHM should he post bail.²

14 Mr. Hudson posted bail on both cases and was released.³ Almost immediately, Mr. Hudson has
15 violated his conditions of release and flaunted it on social media. Mr. Hudson’s Instagram (“IG”)
16 handle was changed from “srt.miles” to “not.srtmiles” within hours of his release. This new IG handle
17 appears to have maintained the same posts as the previous entitled “srt.miles” account.⁴ Many of them
18 show the distinctive Dodge Charger SRT at issue in these cases, as well as Mr. Hudson. At the same
19 time, a new disclaimer appeared on the social media page advertising that Miles, referring to Mr.
20 Hudson, doesn’t post there for legal reasons.

Mr. Hudson also created a brand new account titled “alone.miles.” He has continued to post there, though now using the “story” format, meaning that the photo disappears after twnty-four hours. One such story was captured by a concerned citizen and included in correspondence with the Seattle City Attorneys Office (“SCAO”).⁶ The photo posted to this account depicts an ankle monitor matching the one issued to Mr. Hudson and a set of car keys that match those known to operate the SRT Hellcat owned by Miles Hudson, as well as the distinctive hellcat patterned blanket.⁷ Another civilian captured a similar photo from an IG story posted on Mr. Husdons new account, capturing a different photograph from a wider angle (depicted below).⁸

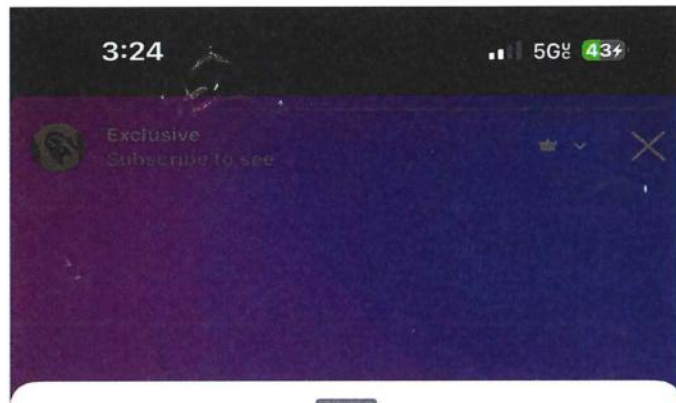


Since July 31, 2024, the City has been receiving correspondence from constituents about Mr. Hudson violating his criminal conditions of release. Citizens have noted the change in IG name, photos posted on IG and Reddit, a new TikTok account entitled “srt.miles,” an adoption of his

1 previous IG handle, and importantly, that Mr. Hudson is now selling subscriber only content under his
2 new “not.srtmiles” handle for \$9.99 a month.⁹ Among the benefits of subscription are exclusive
3 content, behind the scenes access and an “ask me anything” option (depicted below).

While the page is allegedly managed by “@954fastpitchtv,” the exclusive content clearly advertises and provides direct access to Mr. Hudson. This exclusive subscription content did not exist until August 1, 2024.

Another concerned civilian sent a recording of a TikTok clip, posted under the handle “srt.miles,” part of which showed a photo of Mr. Hudson being taken into custody at his July 29th hearing bearing the text “They Freed the Demon” across the photo and the caption “Free me.”



This photo was clearly taken after the court set his conditions of release.

Its clear that Mr. Hudson has violated his conditions of release in multiple ways. Judge Neisen was exceedingly clear that Mr. Hudson is prohibited from personally posting content on instagram and

1 twitch, on any account, and his two preferred accounts, “srt.miles” on instagram and “blitzskii” on
2 twitch, were to remain dormant. In response, Mr. Hudson changed the name of his instagram account
3 and added a disclaimer that he doesn’t post directly there for legal reasons. He began selling a monthly
4 subscription that allows purchasers direct access to unique and new content, advance access to new
5 postings and the ability communicate directly with Mr. Hudson. He has created an entirely new IG
6 account in which he has posted multiple photos of his ankle monitor and car keys as self deleting
7 stories. He has established a TikTok account in which he has begun posting photos taken while inside
8 the courtroom during his hearings. Mr. Hudson has continued to post content across various social
9 media sites in direct violation of this court conditions of release.



12 Pursuant to CrRLJ 3.2(J) and/or (k)(1), the City may by verified application, request the Court
13 to issue a warrant directing the arrest of the accused for immediate hearing for reconsideration of
14 conditions of release pursuant to section (k) of CrRLJ 3.2. The Court should determine custody
15 pending trial and determine a new appropriate bail amount. The City respectfully requests that this
16 Court revoke release and issue a warrant in the amount of \$25,000 for the arrest of the defendant for
17 immediate hearing for reconsideration of conditions of release.¹⁰ In the alternative, if the court is
18 unwilling to issue such a warrant, the City requests the court set a hearing at the earliest opportunity to
19 discuss these violations of Mr. Hudsons conditions of release.

CERTIFICATION IN SUPPORT OF MOTION


That Christopher T. Karr is a Senior Assistant City Prosecutor in and for City of Seattle, and is familiar with the records and files herein;

According to the status report filed by Sentinel on July 30, 2023, the Defendant enrolled for his pretrial EHM obligation on July 30, 2023. Since then, the Seattle City Attorney's Office has received continued correspondence from members of the public who have reported the defendant's change in social media handles and continued posting on social media platforms such as Instagram and TikTok. One screenshot shows the defendant appearing to be posting a photograph of his ankle monitor while holding his car keys. The emails are attached in support of this certification.

The City has consulted with Amy Gries, manager of the Sentinel Offender Services office, who personally viewed photos posted to Mr. Hudson's TikTok account and recognized the EHM ankle monitor she personally installed around Mr. Hudson's ankle.

Under penalty of perjury under the laws of the State of Washington, I certify that the foregoing is true and correct.
