<p>On 10/09/2024 Seattle Municipal Court asked for further information regarding Miles Hudson's leaves during the previous violation report. Mr. Hudson had left multiple times from the dates of 09/13/2024 to 09/30/2024, these leaves include: letting people up, DoorDash, and leaves he cannot remember. On 09/13/2024 Mr. Hudson had a leave from 1:08pm to 1:14pm where he could not remember where he went. On 09/15/2024 Mr. Hudson had three unapproved leaves from 4:06pm to 4:12pm, leaving again at 8:30pm to 8:36pm claiming he was getting DoorDash, and the final leave that day was from 9pm to 9:12pm. On 09/16/2024 Mr. Hudson had three unapproved leaves starting at 2:14am to 2:20am claiming it was DoorDash, the next leave was the same day at 1:57pm to 2:03pm claiming he was letting someone up, the final leave that day was at 9:01pm to 11:45pm stating he could not remember what he was doing during that time. Mr. Hudson has one unapproved leave on 09/17/2024 at 9:52pm to 9:57pm, Mr. Hudson could not remember where he went for those 5 minutes on that day. On 09/19/2024 Mr. Hudson had two unapproved leaves at 8:25pm to 8:35pm, when asked Mr. Hudson could not recall where he went. Mr. Hudson left that same day at 9:03pm to 11:02pm, when asked Mr. Hudson thought it could have been work, but there was no proof of him working that day. On 09/20/2024 Mr. Hudson has one unapproved leave at 3:23am to 3:29am. The next day on 09/21/2024 Mr. Hudson left at 3:34am to 3:41am stating he was letting his sister up. On 09/22/2024 the next day Mr. Hudson had another unapproved leave at 3:15am to 3:21am. On 09/26/2024 Mr. Hudson had once again another unapproved leave at 9:22pm to 9:31pm, stating he went down to grab DoorDash. On 09/27/2024 Mr. Hudson had two unapproved leaves at 3:19am to 3:31am, then leaving again on the same day at 3:44am to 3:50am. The next day on 09/28/2024 Mr. Hudson has three unapproved leaves from 11:57pm to 12:20am stating he was letting someone up, the next was from 3:50am to 3:55am, the final leave that day was at 3:47pm to 4pm. The next day Mr. Hudson has one unapproved leave on 09/29/2024 from 2:19pm to 2:24pm, which he stated it was DoorDash. The next and final leave from this report was on 09/30/2024 at 9:21pm to 9:45pm. During this time from 09/13/2024 to 09/30/2024 Mr. Hudson had failed to provide proof of DoorDash, which is not allowed while on EHM, failed to provide proof for multiple leaves, and failed to provide proof of work from 09/15/2024 to 09/30/2024. Sentinel will continue to monitor Mr. Hudson for any further violations.</p>
