Dear Hon. Damon Shadid, Hon. Andrew Simons, Ms. Davison, Ms. Williams, Ms. Pratt, Mr. Gelfand, Mr. Kettle, Lt. Ward, and Mr. Thomas:

I am writing in regard to *City of Seattle v. Miles Oliver Hudson*, Criminal Case No. 4240000362 and Civil Case No. 1240000005.

At approximately 11:05 PM on Thursday, May 22, I observed Miles Oliver Hudson blatantly violating the Conditions of Release Order signed by the Hon. Andrew Simons on April 9, 2024 ("not to drive Dodge Charger, CKG6773") in the criminal case.

I am attaching as evidence a 22-second video clip, taken at that time, showing Hudson's mother's car--identified by its distinctive custom wrap and excessive gun-like noises--driving down 2nd Avenue and entering the gated garage of West Edge Apartments at 1430 2nd Avenue. This garage can only be accessed by residents, and Hudson is a resident.

Despite this video being taken from 26 floors above street level, more than a block away, and behind double-paned, closed windows, the exceedingly disruptive and gun-like noises Hudson makes using his mother's Dodge Charger can be clearly heard.

The third video clearly shows that Hudson engaging in this disruptive, antisocial, and criminal behavior knowingly, willingly, and intentionally.

These three videos further indicate that Hudson continues to flagrantly violate Title 25 of the Seattle Municipal Code *despite* being served, on May 10, 2024, a complaint for civil penalties describing these very same violations. Accordingly, the fine of \$1,300 per day of noncompliance after April 15 should be revised to include May 22 (37 days x \$1,300 = \$48,100) and continue to accrue.

On May 14, 2024, Hudson's mother Rebecca Hudson submitted to the court in an email, "The defendant Miles Hudson does not have the car in his possession, and I am working on getting the car fixed and up to compliant [sic] [...] This letter

is just informing and responding to you that I am working on it and he is no longer driving the car or having it in his possession."

The videos above show that (1) Hudson, in fact, does have possession of the car and (2) no work was done to make the car anywhere close to being noise-compliant. For making these materially false statements to the court, Rebecca Hudson should be investigated and charged for perjury.
